The Republic of Poland has received financing from the World Bank toward the cost of the Odra-Vistula Flood Management Project, and intends to apply part of the proceeds toward payments under the contract for „**Modernization of uninterrupted power supply systems at the hydrometeorological stations, the weather radars and the Central Laboratory of IMGW-PIB for Measuring Instruments**”

The Institute of Meteorology and Water Management - National Research Institute now invites sealed bids from eligible bidders for:

Task description:

The subject matter of the contract is the delivery, installation and commissioning of power generators, emergency power supplies and fire protection circuit breakers at hydrological and meteorological stations for the locations indicated. The supplied devices will ensure emergency power supply to the station in case of a power failure in the primary network.

The scope of delivery includes the following locations:

As part of the subject matter of the order the Contractor is obliged, in each location mentioned above:

- Execute and then agree with the Employer design of modernization of power supply and fire protection circuit breakers
- Dismantle the existing uninterruptible power supply system
- Supply, install and commission a power generator
- Provide, install and configure emergency power supply unit
- Delivery, installation of the A.M.S. system
- Perform installation works necessary for the proper functioning of the uninterruptible

power supply system

- Provide and execute necessary infrastructure including foundation for generator
- Execute fire protection switch-offs for power generator, emergency power supply unit and additionally for the whole building,
- Prepare and agree with the Distribution System Operator appropriate for the location, the "Operational Cooperation Manual"
- Carry out acceptance tests of the modernized uninterruptible power supply system together with the Employer.
- Produce as-built documentation and make it available to the Employer.
- Provide training on the use of installed equipment
- Provide warranty service on all delivered elements and performed works for the period of 5 years

A detailed description of the Object of the Order is included in the Bidding Documentation.

Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's *Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers* dated January 2011, revised July 2014 ("Procurement Guidelines"), and it is open to all eligible bidders, as defined in the Procurement Guidelines.
