- Replacement of 7 existing meteorological radar systems with new magnetron radios with dual polarization measurement functionality
- Design and construction of a radar station in Uźranki together with the supply, installation and commissioning of a magnetron radar with the functionality of measurements in double polarization.
- Design and construction of a radar station on Góra Św. Anna with the supply, installation and launch of a magnetron radar with the functionality of measurements in double polarization.
- Finding locations, acquiring land, designing and building a radar station that will replace the current location in Gdańsk with the installation and launch of a magnetron radar with the functionality of measurements in double polarization. Disassembly of the radar station in Gdańsk.
- Dismantling of the existing radar station, design and construction of a new radar station in Brzuchania
- Modernization of 6 existing radar stations
- Construction of a warehouse hall at the radar station in Legionowo
- Comprehensive modernization of the buildings of the radar station in Legionowo
- Delivery of a spare parts kit
- Delivery of measuring apparatus
- Supply of tools and power tools
