**Contract Title: POLRAD Weather Radar Modernization**

The Republic of Poland has received financing from the World Bank toward the cost of the Odra-Vistula Flood Management Project, and intends to apply part of the proceeds toward payments under the contract for POLRAD Weather Radar Modernization.

The Institute of Meteorology and Water Management - National Research Institute now invites sealed bids from eligible bidders for:

Task description:

The OVFMP 4A.3.1 contract covers the following scope of work:

- Dismantling of 8 existing radar systems
- Replacement of 7 existing meteorological radar systems with new magnetron radars with dual polarization measurement functionality
- Design and construction of a radar station in Uźranki together with the supply, installation and commissioning of a magnetron radar with the functionality of measurements in double polarization.
- Design and construction of a radar station on Góra Św. Anna with the supply, installation and launch of a magnetron radar with the functionality of measurements in double polarization.
- Finding locations, acquiring land, designing and building a radar station that will replace the current location in Gdańsk with the installation and launch of a magnetron radar with the functionality of measurements in double polarization. Disassembly of the radar station in Gdańsk.
- Dismantling of the existing radar station, design and construction of a new radar station in Brzuchania
- Modernization of 6 existing radar stations
- Construction of a warehouse hall at the radar station in Legionowo
- Comprehensive modernization of the buildings of the radar station in Legionowo
- Delivery of a spare parts kit
- Delivery of measuring apparatus
- Supply of tools and power tools
- It is required that all design work be agreed with the Employer
- Obtaining all the legally required arrangements, notifications, permits, reports etc. required by Polish legislation.
- All work is required to be carried out in accordance with the World Bank standards and requirements, in particular: the Framework Plan for Environmental and Social Affairs Management (final document, April 2015 with subsequent changes in the matter of real-time occupation) and the World Bank's Operational Policy OP 4.12 - Forced resettlements

The investment will be implemented in Poland.

The radar station is located on plot 63 in the village of Brzuchania, Miechów municipal district, Miechów county, Małopolskie voivodeship.

The radar station is located on the Ramża hill in Bełk near Orzesze, Orzesze rural municipality, Miłkowski county, Śląskie voivodship, plot 2012/11.
