The Contractor is required to supply, deliver, install, test, commission and set to work Automatic Radiosonde Systems along with dedicated Automatic Weather Station on the following IMGW-PIB owned aerological stations: Leba (1a Rąbka str., PL-84360 Leba), Wrocław (201 Graniczna str., PL-54530 Wrocław), Zamosc (115 Mokre str., PL-22400 Zamość). The Contractor is also required to train operational and service personnel, to provide long-term service care for installed equipment and to provide radiosondes for the first 2 years of measurements (1460 pcs per station).
