DESCRIPTION (field, expectations, comments):

A person who obtained a doctoral degree in 2010 or subsequent years can enter the competition. The candidate should have the knowledge and professional experience in the field of Earth Science issues, including chemical oceanography and marine chemistry. Should have documented scientific publications, recorded in the Web of Science and Scopus publication databases, and confirmed participation in the implementation of research projects financed from national and foreign funds. The candidate is expected to have: experience in the implementation of works related to marine chemistry research in the field of chemical substances analysis in various elements of the marine environment (including chemical analyzes of environmental samples in the field of chemical substances with particular emphasis on hazardous substances). Candidates should be able to use a computer effectively and have the ability to work with data analysis programs.

Employment on the permanent contract for an indefinite period is offered. Due to legal requirements, the employee will be obliged to sign a statement on participation in research works with the affiliation of the publication at IMGW-PIB.

#### I. Conditions of the competition for the position

Candidates must meet the requirements for appointment as assistant professor posed in the Act of 30<sup>th</sup> April 2010. – about research institutes (Dz.U. 2020 r. poz. 1383, as amended).

    - a list of research projects (national and foreign projects) indicating the candidate role in these works (min. 5 items)
  - Earth science specialization confirmed by:
    - a list of documents (min. 3 items) related to chemical oceanography and sea chemistry, indicating the candidate role in their development in the area of:
      - chemical analyzes of environmental samples in the field of chemical substances with particular emphasis on dangerous substances
