#### DESCRIPTION (field, expectations, comments):

The candidate should have knowledge of Earth and environmental Sciences in the field on meteorology and climatology and modern methods of data analysis at a level that allows independent research in interdisciplinary research teams within the IMGW-PIB, as well as from outside of the Institute, at national and international level. The candidate should have documented scientific publications in the field of Earth and environment science and documented participation in research projects. From the candidate it is expected in particular: experience and suitability to lead research teams, represent the Institute at national and foreign forums, expert activities, developing the cooperation with other national scientific units and international cooperation.

Professor IMGW-PIB will be obliged to sign the declaration of representing of Earth and environment science scientific discipline.

Employment on the permanent contract for an indefinite period. Due to legal requirements, the employee will be obliged to sign a statement on participation in research works with affiliation of the publication at IMGW-PIB.

## **I. Conditions of the competition for the position**

Candidates must meet the requirements for appointment as Professor of the Institute posted in the Act of 30<sup>th</sup> April 2010. – about research institutes (Dz.U. 2020 r. poz. 1383, as amended).

3. Summary of professional accomplishments
4. Education confirmed ownership:
  - Doctor degree with habilitation in Earth and environmental science,
5. Professional experience in the field
  - Conducting research confirmed by :
    - number of publications and scientific and technical reports (min. 7 items), including a minimum of 5 items from the list published by Polish Ministry of Education and Science (MEiN) with the score of at least 70 points each published within the last 3 years , along with the information about the MEiN scoring, Impact Factor, number of citations and the Hirsch index
  - Conducting research in research teams confirmed by:
    - a list of research projects indicating the candidate role in these works (min. 7 items)
  - Earth science specialization confirmed by:
    - a list of documents (min. 10 items) related to geography, meteorology and climatology indicating the candidate role in these works in the area of:
      - data analysis in the field of climate monitoring
      - assessment of the ecological status of the environment
      - the impact of climate change on society, the environment and the economy
      - research on meteorological conditions
      - preparation and analysis of climate change projections
      - analysis of extreme events occurrence
6. The professional qualifications confirmed by:
  - participation in scientific conferences, seminars and symposia (including international)
  - certificates of completed trainings, workshops, etc.
7. Knowledge of a foreign language
  - statement of candidates skills/competence in foreign languages
  - for foreigners the required knowledge of the Polish language - C1 level
8. Signed information clause.

**III. The competition will be conducted in the form of an interview, during which the candidate knowledge in the field of Earth and environment science discipline will be checked.**
